ALTERNATE LIST – Any entries remaining will be placed onto the Alternate List as determined by a random draw. Entries from the Alternate List may fill any absentee spaces at the time of the draw for tracks. The person making the entry shall be notified of their position on the Alternate List. Entries will be refunded within ten (10) days of the match to those on the Alternate List who did not participate in the Test.

A certificate will be awarded to each dog successfully completing a Test.

NON-MEMBER PARTICIPATION FEE - Effective January 1, 2011 An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled
